**IMPORTANT INSTRUCTIONS FOR STUDENTS/CONSTITUENT UNITS**

1. Xerox copies to be self attested by the applicant and verified by respective HOIs.
2. Original Migration to be submitted with the Eligibility forms in the University.
3. \*Original TC and Gap Certificate to be deposited in the respective Constituent units.
4. \*Photocopy of TC and Gap Certificate to be deposited in the University with the Eligibility forms.
5. The application form must be filled in by the applicant in his/her own handwriting.
6. The applicant should read the ordinances, regulations etc. pertaining to course/exam to which he/she is seeking admission.
7. Institute must ensure that prima facie the applicant is eligible for admission as per the ordinances of People's University.
8. Students having obtained their qualifications from abroad or under foreign system in India are required to obtain an Equivalence Certificate from Association of Indian Universities (AIU).
9. The Marks List / Certificate signed by the examination conducting authority only will be the valid documents and internet Marks card copy cannot be accepted for issue of Eligibility certificate.
10. Incomplete applications will be rejected.
11. The constituent unit should give admissions to students from board and universities only after ascertaining and ensuring that their qualification examinations are approved by the COBSE/UGC/AIU/IAU on the websites of the concerned bodies or boards.
