1. PCDS & RC Bhopal and Bansal Hospital will identify research opportunities to conduct cooperative research and experimental programmes for the mutual benefits.

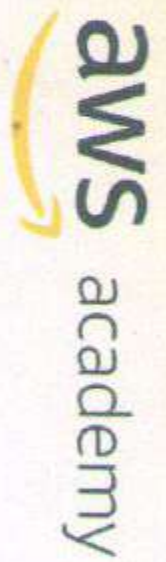
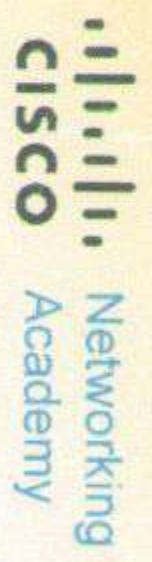
