Observations and Recommendations:

- 2. The RAC of colleges while approving the "synopsis" of a PG thesis should discuss the requirement of laboratory experiments, which could be supplemented in the study and can be implemented in collaboration with the Director, CSRD. Dean, PCMS & RC, PCDS & RC, and PDA in cooordination with the Director, CSRD, must arrange for their HoDs to visit CSRD and become acquainted with the existing lab facilities.
- 3. Research Coordinator presents "Call for Research Proposals" notified by the Government of India Departments (eg. ICMR, DST, DBT etc.) in every College Council meeting(s) as a permanent agenda item, so that HoDs can take initiatives for the development of inter/intra Institute projects.
- 4. Internship of UG & PG Students in People's Hospital: The period, attendance and structure of internship for students of MBA (HA), BPT, BMLT, DDT, DMLT, B.Pharm & D.Pharm in People's Hospital to be well defined. The interns are to be given weekly schedule in advance for their training alongwith duty hours. The attendance verification by People's Hospital to be made mandatory for interns. Accordingly the HoIs to individually interact with Medical Suprintendent, People's Hospital to finalise the logistics.
