As the quorum was completed, the meeting started with welcome address by Hon'ble Vice-Chancellor.

Following agenda was discussed:-

1. Amendment in Ph.D Ordinance No. 41, MPT Ordinance No. 50

(a) Amendment in PhD ordinance no.41.

Dean Academic Affairs proposed amendment in PhD ordinance no.41 - prominent changes include.

(i) Clause no. 13 regarding eligibility of supervisor/co-supervisor in Faculty of Medicine, Dentistry & Nursing - to fix the eligibility to 8 years teaching experience in above mentioned faculties, after completion of post-graduation degree in respective subjects.

(ii) The minimum time period including course work will be three years from date of admission as per UGC regulation 2016.

The members of Academic council approved all the amendments in ordinance 41.

(b) Amendment in MPT ordinance no.50.

Dean Faculty of Paramedical Sciences proposed amendments in clause 5.2. Hon'ble Vice Chancellor suggested that the classes shall officially commence on from December. All members approved the amendment.

Amendments in clause 13.4 & 13.5 were discussed and approved.

Amendments in clause 7.1 and 9.2 need further deliberations and was deferred to next meeting.

2. Review of status of all Constituent Units towards preparation for fresh application for reassessment to NAAC

Director I.Q.A.C informed the Council that the 2nd round of Internal Academic Audits will commence from 01/04/2019. All the HOIs were requested to submit the Part B of I.Q.A.C form positively by 31/03/2018 and to keep the institutions ready for inspection.

3. Dean Faculty of Dentistry informed the Academic Council regarding initiation of the following certificate courses to be conducted in PCDS&RC

a) Implantology Course

b) Tobacco de-addiction and cessation training programme.

c) Conscious Sedation Course.

After due deliberations, the Academic Council requested the Chairman BOS Dentistry to submit the syllabus & Scheme of examination before the next Academic Council/Standing Committee of Academic Council.

4. (a) Introduction of new courses: M. Tech in Production Technology

Hon'ble Vice Chancellor suggested that the title of the new MTech course proposed may be changed to MTech Production Engineering instead of Production Technology.

All members approved the introduction of the new course.



(b) Amendments in Ordinances: Inviting industry expert as External Examiner to conduct M. Tech Examinations (all streams) of engineering

COE was requested to determine the feasibility of the proposed amendments in ordinance and put up in the next meeting.

(c) Scheme & syllabus revision of B.Tech, M.Tech& Diploma courses (all branches all semester) as per UGC, NAAC and AICTE guidelines

Dean. Faculty of Engineering proposed Scheme & syllabus revision of B.Tech. M.Tech& Diploma courses (all branches all semester).

Members of the Academic Council approved the proposed revision of syllabus and scheme of examination.

5. (a) Approval of scheme & syllabus of new programmes of MBA (Logistic & Supply Chain Management) in collaboration with safeducate, the Academic wing of safexpress

Dean Faculty of Management proposed starting of new branch of MBA- (Logistic & Supply Chain Management). He also proposed the Scheme & syllabus of the same

Members of Academic Council approved it.

(b) Dean Faculty of Management also proposed the following new course.

(i) M.Com with intake of 15 seats.

(ii) B.Com, MBA (integrated) with intake of 15 seats.

-Hon'ble Vice Chancellor suggested that an exit clause may be added during admission to encourage students to continue the course after B.Com.

-COE suggested that there should be uniform fees in all the semester of the integrated course.

(iii) Diploma in Food production & Patisserie with 15 seats

(iv) Diploma in Food & Beverage Service with 15 seats

Dean, faculty of Management was requested to submit the duly approved ordinances for all these courses Members of Academic Council approved it.

6. Introduction of one year certificate courses on Pharmaco-vigilance, Medical Writing and Clinical Research and Data Management

Dean Faculty of Pharmacy proposed the commencement of the above mentioned one year Certificate course.

Members of Academic Council approved it.

7. Integration of Middle level Health Provider (M.L.H.P.) in Basis B.Sc.(N) & Post Basic B.Sc.(N) Curriculum

Dean, Faculty of Nursing proposed the integration of MLHP in basic BSc (N) and post Basic BSc (N) curriculum as per guidelines of Nursing Council of India.

Members of Academic Council approved it.



8. Review of preparation of PCMS department for forthcoming MCI inspection for continuation of recognition for MD/MS degree

Dean PCMS was requested to submit Physical & Academic requirements for forthcoming MCI inspections by 10/04/2019.

9. Proposal from Examination Committee

First Minutes of Meeting of Examination committee held on 14/03/2019 was submitted to Academic council for approval. Academic Council approved 1st Minutes of meeting of exam committee.

10. Proposal to start B.A, M.A., 3Year LLB, 5 Year Integrated LLB and LLM Courses

Dean Student Welfare, due to frequent enquiry from students, proposed the commencement of the following courses along with the Ordinances.

- (a) LLM in Criminal Law, Human Rights, Intellectual Property & Cyber Law
- (b) LLB – 3 Year course
- (c) Integrated LLB – 5 Year course
- (d) MA- English, Business Economics and Psychology
- (e) BA- English Literature (Hons) and Economics (Hons)
- (f) Master of Social Work (MSW)

Members of Academic Council approved the ordinances of the above mentioned programs.

Any other matter with the permission of the chair.

11. Value Added Course

a. Dean Faculty of Dentistry proposed the following value added course to be conducted in PDA

1. Certificate Course on Basic Research Methodology
2. Certificate Course on Psychological counselling Guidance
3. Certificate Course on Histopathology training for technicians
4. Certificate Course on Forensic Odontology
5. Fellowship Course on Forensic Odontology

Members of Academic Council requested the Chairman BOS Dentistry to submit the syllabus & Scheme of examination before the next Academic Council/Standing Committee of Academic Council.

b. Hon'ble Vice Chancellor proposed that business English Certificate Course from Cambridge University may be made introduced as value added course for all the I year students of the University except for students under Faculty of Medicine. All other HOIs to examine the feasibility and submit their report by 15th April 2019. He advised all HOIs to Co-ordinate with Dr. Sameer Sharma, Director PIMR for conduction of the course for their students.



12. Introduction of CBCS

- a. Hon'ble Vice-Chancellor instructed the Dean Faculties to induct CBCS in those programmes where Semester system is followed, as it will help the students to select the subjects of their choice. All HOIs to submit their proposal for academic session 2019-20, by **20th April 2019**.
- b. Introduction of Choice Based Credit System (CBCS) in MSc courses: After due deliberations, the committee approved introduction of CBCS in the MSc – Microbiology and MSc Biotechnology courses. The scheme & syllabus of these courses was approved by the council.

13. Addition of Faculty in Statute No. 12

Faculties of the University: with the view of initiating courses, Registrar, PU proposed the addition of the following Faculties in Statute No.12 –

- i. Law
- ii. Alternate Medicine
- iii. Music & Fine arts
- iv. Veterinary & Animal Husbandry
- v. Agricultural sciences
- vi. Humanities and Social Sciences.


14. Adjunct Faculty
