Automation is introduced in Pathology, Biochemistry and Microbiological laboratories. Medical Records are maintained as per ICD 10 classification which forms a huge resource for all research activities in the institute. This hospital is designed and functions as per regulatory body norms.

Academic activities include predominantly clinical interactive teaching for both undergraduates and postgraduate students along with regular faculty updates. Academic infrastructure constitutes clinical demonstration room in both OPD and IPD areas, departmental libraries and research laboratories so that each department functions as an independent academic unit. All faculties are trained in medical education technology and provide hands on training for postgraduate students. Clinical skill labs for students are operational and are over &above the regulatory body norms.

People's Hospital is associated hospital of People's College of Medical Sciences & Research Centre which caters to the local needs by practicing cost effective evidence based management of clinical cases.

The hospital has 1350 operational beds spread in five blocks with well-equipped Casualty, ICUs, Operation Theaters and Central Pathology laboratories. Automation is introduced in Pathology, Biochemistry and Microbiological laboratories. Medical Records are maintained as per ICD 10 classification which forms a huge resource for all research activities in the institute. This hospital is designed and functions as per regulatory body norms.

Academic activities include predominantly clinical interactive teaching for both undergraduates and postgraduate students along with regular faculty updates. Academic infrastructure constitutes clinical demonstration room in both OPD and IPD areas, departmental libraries and research laboratories so that each

department functions as an independent academic unit. All faculties are trained in medical education technology and provide hands on training for postgraduate students. Clinical skill labs for students are operational and are over &above the regulatory body norms.
