Subject: Regarding curbing the menace of ragging in higher Educational Institutions-Implementation of Regulations of UGC/Statutory bodies/ Hon'ble apex Court, in toto.

In pursuance to the judgment of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009 & in compliance to U.G.C. earlier guidelines it is herewith emphasized to implement in toto "UGC regulations on curbing the menace of ragging in higher Educational Institutions 2009" as mandatory steps including the monitoring mechanisms in order to "Prohibit, Prevent & eliminate the scourge of the ragging" & to maintain "Zero Ragging & Zero Tolerance Status" in all institutes of People's University."

Heads of Institutions are instructed to strengthen Constitution of their Anti-Ragging Committees & Anti-Ragging Squads as per above regulations. All the Institutions & Anti Ragging Committees of the University are instructed to step up anti-ragging mechanisms by way of adequate publicity through various mediums, action-packed anti-ragging committees and anti ragging squads, quick-response system, CCTV cameras at vital points, alarm bells, regular interaction and counselling, identification of trouble triggers, prominence to anti-ragging in the institution's prospectus and information booklets/brochures, surprise inspection of hostels, students accommodation, Canteens, rest cum recreational rooms, toilets, bus stands and any other measures which would augur well in preventing/quelling ragging and any uncalled for behaviour/incidence. The students and the parent/guardian community may also be made aware of the anti-ragging helpline, anti-ragging website, anti-ragging monitoring agency and all Universities/Colleges/Institutions should take necessary steps. Besides above steps, Anonymous random surveys, maintaining confidentiality of whistle blowers, mentors- mentee programme & Foster Parents for fresher's etc. are also to be implemented. All the Heads of Institutions are instructed that the students /parents ought to know whom to call and approach with alternative contact nos. when in difficulty.

Educational institutions of People's University are being instructed to re-ensure that they have a tight anti-ragging system. Students in distress owing to ragging related incidents can access the **National Anti-Ragging Helpline 1800-180-5522 (Toll Free or E-Mail the Anti-Ragging Helpline at helpline@antiragging.in**. For any other information regarding ragging UGC web-site www.ugc.ac.in & www.antiragging.in may be visited and UGC Monitoring agency i.e. Aman Satya Kachroo on following No. 09871170303, 09818400116 may be contacted (only in case of emergency). Heads of Institutions must display must display these numbers & E-Mail addresses along with Anti-ragging posters at all prominent places.

Besides above Anti-Ragging measures Head of Institutions & University Monitoring Cell/Anti-Ragging Cell are instructed to ensure all the Anti- Ragging measures to completely curb the menace of Ragging as per Instruction of Hon'ble Supreme Court of India/Statutory bodies such as MCI, DCI, AICTE, NCI, PCI, M.P. Private Universities Regulatory Commission M.P. Paramedical Council Issued from time to time & to implement measure for prevention of ragging at institutional level before admission, on admission & at end of the admission year along with effective working of Anti-Ragging committees & squads. For eradication of ragging menace you are also requested to hold workshops, seminars regularly and display the updated contact details of Anti- Ragging Committee, Anti-Ragging Squad, Hostel Wardens, Nodal Officers on the Website.

In compliance of the 2nd Amendment in UGC regulations, all Heads of Institutions shall make it compulsory for each student and every parent to submit an online undertaking every academic year at www.antiragging.in & www.amanmovement.org. In case of any ragging complaint you are requested to sent the Anti- Ragging committee report in enclosed UGC prescribed format to the undersigned for onward transmission of the same to the UGC, new Delhi.

UGC has notified the 3rd Amendment in UGC Regulations on 29th June, 2016 to expand the definition of ragging by including the following:

3(J). Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

You are hereby instructed to implement above instructions & regulations of Hon'ble Apex Court of India, U.G.C & Statutory bodies in toto so as to completely curb the menace of ragging & to maintain "Zero Ragging & Zero Tolerance" Status of the University.

Any violation of these regulations will be viewed seriously. If any institution fails to take adequate steps to prevent ragging or does not act in accordance with these regulations or fails to punish perpetrators of incidents of ragging suitably, it will attract punitive action against itself by the UGC.
